Uittreksel uit Grondwet

Enige verbonde persoon wat regstreeks met 'n Gewone Lid gemeed is met die teelt van Brahmanbeeste, kan vir lidmaatskap as 'n sub-lid aansoek doen. Sodanige lid sal geag word as:

- (i) 'n verbonde persoon te wees indien hy of sy op enige van die volgende wyses 'n verbintenis het, naamlik- 'n kind, (ook aangetroude kinders) kleinkind, agterkleinkind, ouer of grootouer, of 'n trust, mits die trustees en die kapitaal- en inkomste begunstigdes 'n verbonde persoon is, met dien verstande dat die lid jaarliks voor 28 Februarie aan die Genootskap bevestig dat daar geen verandering in terme van die trustees en/of begunstigdes as verbonde persone plaasgevind het nie. En met dien verstande verder dat sodanige persoon nie 'n geskorste lid is ingevolge artikel 8 nie of indien daar 'n verandering plaasgevind het dit geskied het met goedkeuring van die Raad ingevolge artikel 3.3.2 – (*Alle stukke wat aan sodanige gevolmagtigde verteenwoordiger, soos in Klousule 3.3.1 uiteengesit, gerig is, word beskou as behoorlik op die vennootskap, trust of regspersoon bestel te wees en by alle vergaderings wat deur sodanige gevolmagtigde verteenwoordiger namens die vennootskap, trust of regspersoon bygewoon word, word die vennootskap, trust of regspersoon beskou as behoorlik verteenwoordig te wees.*) Enige persoon van die klas in die klousule beskryf wie se lidmaatskap opgeskort of beëindig is sal nie as verbonde persoon kwalifiseer nie. Indien die sub-lid op grond van die voorgaande gediskwalifiseer is sal sy sub-lidmaatskap verval;
- (ii) en sal die reg hê om alle vergaderings van lede van die Genootskap, insluitende Algemene Jaarvergadering van die Genootskap, by te woon, aan besprekings deel te neem en stemreg hê mits aan die vereistes, soos uiteengesit in Klousule 3.4.2 (*Aansoek om sub-lidmaatskap van die Genootskap as sub-lid van 'n Gewone Lid moet op die voorgeskrewe vorm (Skedule E1) aan die Genootskap gerig word. Die aansoek moet ook vergesel gaan van die betrokke subskripsie- en intreegelde soos in die bylae van gelde uiteengesit*) met betrekking tot die betaal van subskripsie- en intreegelde, voldoen ;
- (iii) indien so 'n sub-lid in gebreke sou bly om aan die vereistes soos uiteengesit in Klousule 3.4.2 te voldoen, sal sodanige sub-lid bloot die reg hê om alle vergaderings van lede van die Genootskap, insluitende die Algemene Jaarvergadering van die Genootskap, by te woon, aan besprekings deel te neem maar sal nie stemreg hê nie;

SUB-MEMBERSHIP



The costs involved in a Sub-Membership is as follows:

Annual Membership fee of R6334.86 VAT incl. (*Only if the sub-member wants to vote at the Annual General Meeting*)

If no voting rights are required, then the Membership Fee is not applicable.

Annual Levy Fees in respect of animals in your possession. These fees will be debited to your account on the 1st of March of every Financial Year.

Excerpt from Constitution

Any involved person who is associated directly with an Ordinary Member in breeding Brahman cattle, can apply for membership as a sub-member. Such a member will be regarded as:

- (i) An involved person if he or she is related in any of the following ways, namely:-
as a child (also children who are related by marriage), a grandchild, a great grandchild, parent or grandparent, or a trust, provided that the trustees and the capital and income beneficiaries are an involved person, and provided that annually, the member will confirm with the Society, before 28 February, that there have been no changes in terms of the trustees and/or beneficiaries as involved persons, and provided, furthermore, that such a person is not an expelled member in terms of section 8, or if a change has occurred, this will happen with the approval of the Council in terms of section 3.3.2. Any person of the class, described in the clause, whose membership has been suspended or terminated, will not qualify as an involved person. If, on the basis of the preceding, the sub-member is disqualified, his sub-membership will lapse.
 - (ii) and will have the right to attend all meetings of members, including the Annual General Meeting of the Society, to participate in discussions, and have the right to vote provided that the requirements, stipulated in Clause 3.3.2 on the payment of subscription and entrance fees, have been met.
If such a sub-member does not meet the requirements, outlined in Clause 3.3.2, (*All documents that are directed at such a fully authorized representative, as outlined in Clause 3.2.1, (Ordinary Member) are regarded as duly served on the partnership, trust or legal entity, and at all meetings that are attended by such a fully authorized representative on behalf of the partnership, trust or legal person, the partnership, trust or legal entity is regarded as duly represented.*)
 - (iii) such a sub-member will merely have the right to attend all meetings of members of the Society, including the Annual General Meeting of the Society, and participate in discussions; however, the person will not have the right to vote.
